From the CEO

It is great to see a number of old faces back in the Tourist Park with the return of many of our regular visitors as well as people exploring our region for the first time. Welcome to all, we hope you enjoy all Cue has to offer.

The Shire has started opening a number of historic buildings at regular times to allow tourists and travellers the opportunity to see inside these iconic places. The Railway building, Bank building and Masonic Lodge building are now open at regular times for public viewing. Check out the Shire notice boards or visitors centre for opening times.

Works have commenced on the expansion of the Cue townsite dual use pathway network. Funding from the WA Bicycle Network Grants program through the Department of Transport and the Shire of Cue will be utilised to build pathways along Railway Street, Robinson Street and part of Wittenoom Street providing links to the Youth and Community Centre located at the town oval.

The Local Government Extraordinary Election day is Friday 21 June, there are three candidates nominated to fill one vacancy on Council. Local Government Election Voting Papers have been posted out by the WA Electoral Commission. If you are eligible to vote in the Cue electorate and haven't received one, please come into the Shire Administration Office where we can issue a replacement. Also located at the Office is the Ballot Box where you can place your completed Voting Papers.

Over forty people attended Little Red in the Hood who performed at the Shire Hall on Wednesday 22 May 2024. The Shire provided food and drinks and the audience enjoyed a comedy show that taught the children about recycling.

Congratulations to the Community Resource Centre for hosting another great Biggest Morning Tea to raise money for the Cancer Council. It was a fabulous turn out of people and food. Around sixty people attended the event to raise over \$1,300 on the day for cancer research.

Barefoot bowls is on every Wednesday night from 6.30pm to 8,30pm. Everyone is welcome to attend this free event with all equipment provided. It is great to see the numbers growing over the weeks.

Council News

Hi to all 'Dryblower' readers,

How the time gets away from us all as we head towards the end of another financial year.

There has been a lot of recent Local Government activity both at the Shire of Cue level and at the Western Australian Local Government Association ('WALGA') level.

May 2024 started off with WALGA holding a Zone Chair Induction workshop at its premises in West Leederville. For those readers who are not familiar with the structure of our Local Government system in Western Australia, WALGA represents all 139 Local Governments across the State with the aim of advocating to the State Government on the many issues that confront the sector. The State is broken up into 17 Zones of which represent all Local Governments, of which there are 12 Country Zones and 5 Metropolitan Zones. Each of those Zones represent a number of Local Governments in their respective regions. I have the role of representing the Murchison Country Zone on the State Council of the Western Australian Local Government Association ('WALGA').

The Zone Chair Induction Workshop was held on 30th April 2024. This was about understanding the Governance structure of WALGA and the process by which the various Zones conduct their regional business which filter through to the WALGA Policy Teams and ultimately WALGA State Council the various issues and matters of importance within each of the Local Government regions. If there is significant State and Local Government interest, then an advocacy position is adopted and put to the various levels of State Government.

On 1st May 2024 I attended the WALGA State Council meeting and North Metropolitan Zone Meeting which was held at the City of Wanneroo. During the two days I also attended WALGA's Environment Policy Team Meeting where all WALGA environmental issues are discussed, policies developed and submissions to State Council are prepared and eventually become the basis for an advocacy position to the WA State Government.

Attending the North Metropolitan Zone meeting gives WALGA State Councillors the opportunity to see firsthand what is happening at the Metropolitan Local Government level. The Cities of Wanneroo, Joondalup and Stirling are members of that Zone, and it is interesting to see the progress and development that is taking place in that part of the State. State Councillors are always mindful that both Country and Metropolitan must work together if we are to be successful at promoting the various causes that come across the table.

From a WALGA State Council perspective the meeting received a progress report on the 'Regional Telecommunications Review and Enquiry' which is currently underway and chaired by former WA and Federal Government Minister Alannah MacTiernan.

All regional and peri-urban Local Governments were invited to provide information for a WALGA submission and to make submissions directly. The 2024 Regional Telecommunications Review submission identifies 12 recommendations that respond to the key issues faced by peri-urban, rural and remote Local Governments.

Telecommunications services are of critical importance to Local Governments, enabling delivery of emergency management responsibilities, economic development objectives and

community aspirations for safe, attractive, liveable places. Local Governments in regional, rural and remote Western Australia report that access to telecommunications services is not equitable across Australia in relation to:

- mobile service coverage;
- choice and therefore cost of mobile service provider;
- speed, capacity and cost of internet services; and
- reliability and resilience of mobile and broadband services

We in the regions experience significant mobile coverage issues and it is hoped that this review will improve those services with significant investment from both the State and Federal Governments.

The meeting also endorsed a new Waste Levy Advocacy position around the Waste Avoidance and Resource Recovery Levy (the 'WARR' Levy) which was established in WA to fund programs relating to the management, reduction, reuse, recycling, monitoring or measurement of waste and administering the fund. The current Levy is applied to waste generated, or landfilled, in the Perth metropolitan area.

WALGA is advocating that the Levy should not be applied to licensed landfills outside the metropolitan area. Let us hope that this position is adopted by the WA State Government so as to avoid a further charge to ratepayers which the State Government will expect all Local Governments to collect on their behalf. I will keep you posted on the progress of this discussion.

The meeting also addressed a paper on the House of Representatives Standing Committee on Regional Development, Infrastructure and Transport (The Committee) which announced an inquiry into Local Government sustainability following a referral from the Minister for Infrastructure, Transport, Regional Development and Local Government, the Hon Catherine King MP. The Terms of Reference identified the following areas of focus:

- The financial sustainability and funding of local government
- The changing infrastructure and service delivery obligations of local government
- Any structural impediments to security for local government workers and infrastructure and service delivery
- Trends in the attraction and retention of a skilled workforce in the local government sector, including impacts of labour hire practices.
- The role of the Australian Government in addressing issues raised in relation to the above
- Other relevant issues.

I hope that the Federal Government will take notice of the various issues that impact Local Governments across the country.

On 2nd May 2024 I attended a planning workshop centred on WALGA's current 2020-2025 Strategic Plan which is again due for review. WALGA will be undertaking a strategic planning process over the course of 2024. The new Strategic Plan will guide the Association's strategic direction and priorities for the next five years. As presented at the March 2024 Strategic Forum, State Council will play a pivotal role in this strategic planning process.

The Shire of Cue held its monthly Council Forum on 14th May 2024 which gives Councillors the opportunity to discuss all matters which currently on the Shire agenda and bring to the table other ideas which will improve our town both as a business and tourist destination.

Ratepayers who wish to contribute to the direction our town is taking should make their views known to the local Councillors or the CEO at the Shire Administration office so that consideration can be given to those ideas.

On 21st May 2024 I attended the Biggest Morning Tea which was held at the CRC in the new gazebo. This was a great event and attended by about 50 people from the town and visitors staying at the caravan park.

Australia's Biggest Morning Tea is Cancer Council Australia's most popular fundraising event and the largest, and most successful event of its kind in Australia. This year the Cancer Council is hoping to raise over \$15 million, to fund research, prevention and support services for those affected by cancer.



On 21st May 2024 I attended the Shire of Cue Audit Entrance Meeting. This meeting is held in conjunction with the Shire Auditors and the Office of the Auditor General. It is a precursor to the conduct of the Shire audit and sets about identifying the various matters that will be looked at during the audit process. I am always pleased to receive audit outcomes and readers should be aware that our Shire has an exceptional track record when it comes to audit and financial management. For this we thank the CEO and his finance staff.

Again, on 21st May 2024 I presided over the Monthly Shire Council meeting. Please feel free to access the Shire website to view the Agenda and Minutes that related to that meeting.

As you probably know by now the Shire is about to hold the Extraordinary Council Election for one Councillor vacancy following the resignation of former Cue Primary School headmaster Neil Montgomery in February 2024. The election will be held on 21st June 2024, and I encourage all eligible ratepayers to be part of the voting process. This is your opportunity to elect our 7th Shire Councillor. We have three (3) nominations whose profiles can be viewed on the public notice board at the Shire Office.

These nominees have taken the time to contest the election and ultimately make themselves available to carry our Shire Council duties and we have a responsibility to be part of that process by voting for that person who you will fee will best undertake that role.

On 23rd May 2024 I attended the Cue Rifle Club meeting at the St' John Ambulance Centre. Although not a Council business activity, I felt that it was important to be part of a renewed club which has a long and successful history in our region. Our Association has now been given the green light to reform and it is hoped that our rifle range will be upgraded, and a successful club is once again happening in Cue. It was very pleasing to see that several residents from Mt. Magnet also attended the meeting.

On 27th May 2024 I attended the community baiting racks at Yarraquin Station. This activity is an essential part of the control of wild dogs within our pastoral leases which impact the business enterprises of all pastoralists. It was pleasing to see the CEO attend and meet pastoralists and take the opportunity to discuss matters that affect them.





On 29th May 2024 I attended WALGA's Environment Policy Team Meeting where we considered a policy position for State Council's consideration around the Caravan and Camping Ground Regulations. Tiny Homes on Wheels ('THOW') are an emerging form of housing that offers affordable housing options that would assist in addressing the immediate housing shortage. THOW's are classified as caravans under the *Caravan Parks and Camping Grounds Act 1995* and the *Caravan and Parks and Camping Grounds Act 1995* and the *Caravan and Parks and Camping Grounds Regulations* 1997. It is proposed that changes to the Act and the Regulations be made to allow camping on private property for a period greater than three (3) months and allow Local Governments to establish a policy to guide approvals beyond three (3) months.

Please feel free to contact any of your local Councillors to discuss any matters that you would like Council to consider. It is important that we, as Councillors, get to know and understand the direction and pathway you would like out town and Shire to head down.

1 in 15 Australians are diagnosed with Bowel Cancer every year.

Living a healthy and fulfilling life is important to us all. But ignoring our health and not seeing a doctor if we have unusual symptoms could have a serious impact on our life and wellbeing. It is important to be aware of cancer symptoms and get checked out by a doctor, clinic nurse or Aboriginal health worker if you notice anything unusual.

Bowel cancer is Australia's second biggest cancer killer, and many people don't realise it kills more Australians each year than breast, prostate, or skin cancer.

Common symptoms of bowel cancer may include blood in your poo (even just one time) or, for more than four weeks: a new pain, lump or swelling in your tummy; feeling tired; looking pale; losing weight without trying; and a change in normal bowel habits, such as runny poo, pooing more often or finding it hard to poo.

Almost half of all bowel cancers can be prevented by leading a healthy lifestyle, which includes:

Eating well – a diet high in fibre, fruit, vegetables and low in red and processed meat Keeping at a healthy weight Not smoking Consuming less alcohol Moving more – be physically active And of course, participating in the screening program if eligible
